Notice of Receivership – Re: Stratford Underwriting Agency Inc. ("Stratford")

We write to provide notice to the current and former Four Points Insurance Company Ltd. ("**FPI**") and Everest Insurance Company of Canada ("**EVCAN**" and collectively with FPI, the "**Insurers**") policyholders of auto insurance policies (a "**Policy**" or "**Policies**") with claims administered or brokered by Stratford (the "**Policyholders**").

On January 31, 2025, Stratford's insurance license was suspended by the Insurance Council of British Columbia. On February 25, 2025, the Supreme Court of British Columbia, granted an order (the "**Receivership Order**") appointing Ernst & Young Inc. ("**EY**") as receiver (the "**Receiver**") of all the assets, undertakings and property of Stratford. The Receivership Order was sought by the Insurers to, amongst other things, ensure the claims of Policyholders, are properly transferred to new administrators for continued administration of the policies previously administered by Stratford.

The auto insurance policies held by the Policyholders are now being administered by the Insurers. No action is required by the Policyholders with respect to your auto insurance policy, at this time.
